### **RV CAMPING RULES AND REGULATIONS**

Welcome to the Alameda County Fair Fairgrounds RV Park. In order to make your stay and the stay of other RV campers a pleasant experience, we ask that you observe the following rules and regulations of the RV Park.

#### **EMERGENCY**

Please notify the following offices of any conditions requiring immediate attention.

#### **RATES**

- **\$28.00 per night 30 amp service (except for certain events during the year)**
- **\$33.00 per night 50 amp service (except for certain events during the year)**
- **\$43.00 per night 30 amp service pull through (except for certain events during the year)**
- **\$48.00 per night 50 amp service pull through (except for certain events during the year)**
- **\$6.00 per night per additional vehicle**

#### **REGISTRATION & PAYMENT**

- Check-In time is 11:30am.
- RV Rates are per site per night. Each site is authorized for 1 RV and 1 vehicle per site; any additional vehicles must pay \$6.00 per vehicle per night.
- Rental fees must be paid in advance upon arrival for all nights, at the Administration Office, 4501 Pleasanton Ave., off Bernal Ave., during normal business hours Monday – Friday (8:30am to 4:30pm).
- After normal business hours you can register at Gate 12 (off Valley Ave.) between 4:00pm and 5:00am Monday – Friday. The Security Officer at Gate 12 can only accept a one-night registration; any additional nights must be arranged with the Administration Office the next day.
- On Weekends and Holidays you may register your RV with the Security Officer at Gate 12 between 12:00pm and 5:00am, for up to 3 nights. Any additional nights must be arranged with the Administration Office the next business day.
- Payment at Gate 12 must be in cash or check. No credit cards. Any credit card transactions must be paid at the Administration Office during normal business hours, prior to your stay.
- NO REFUNDS are issued for cancelled nights.

#### **Check out time/Length of Stay**

- **Check out time is 11:00am. Guests must pay for additional nights prior to 11:00am or will be charged a \$10.00 late fee, \$5.00 for Stable personnel.**
- If you would like late Checkout, you must arrange with front office in advance.
- RV's may stay up to a maximum of 21 consecutive days in one site. Guests staying more than 21 days will be required to move sites and be approved as a long-term camper through management with a contract that approves them in the new site for 60 days. They will then be required to move sites every 60 days

## **Rules and Regulations**

- **Speed limit is 5 mph.**
- Quiet hours are from 10:00pm to 6:00am.
- Permits are required for all RV's and vehicles, and must be displayed at all times.
- Drugs, weapons, fighting, lewd conduct, reckless driving, speeding, roller blading, bikes, scooters, or skateboarding are not permitted.
- Selling, advertising, or distribution of any product (including alcohol) is prohibited.
- Non-contained fires for cooking or heating are not permitted.
- Any type of fencing, barriers, pallets, and etc.- are not permitted.
- No storage of any type allowed around, under or on top of your RV.
- All RV sites must be kept neat and clean for the enjoyment of all occupants. **No stacking of boxes, ice chests, numerous plants, etc.**
- Camper shells must remain on trucks at all times.
- No vehicle repairs of any kind are authorized.
- No loitering in park.
- **RV's taking more than one marked site will be charged for additional site used.**
- **Only one RV and one vehicle per site. No parking in empty sites.**
- Guests visiting RV occupants during any **Fairground Event** will be charged a parking fee of \$8.00
- **Pets are to be kept on a leash (max 10ft) at all times and cannot be tied to a vehicle,fence.**
- Pets left alone must be in a secured Kennel or Dog Pen. This will ensure the dog/pet is not a threat to fellow guests and/or other pets.
- Pets are prohibited in the restroom or on the Fairgrounds (other than RV Park.)
- **You must clean up after your pet; failure to do so may result in eviction.**
- Any guest, their children, their pets or their visitors who become a nuisance will be asked to leave the grounds.
- RV occupants and their guests must obey all posted rules and regulations, as well as any direction given by **ALAMEDA COUNTY FAIRGROUNDS** security department. Failure to comply with the Fairground regulations can result in eviction or other action.
- Only modern independent RV's are allowed. Management reserves the right to refuse occupancy to any trailer when the age, size, or appearance of their recreational vehicle is not compatible with the RV Park.
- Use of the facilities and equipment will be at the guest and visitors own risk. Neither the owners nor the management can be held responsible for accident, injuries, or loss of property due to fire, theft, accidents, or an act of God. You assume all of the risks associated with entering this park not limited to but including your persons, your animals and your vehicles.

**NOTICE: PURSUANT TO THE CALIFORNIA RECREATIONAL VEHICLE OCCUPANCY LAW, THE RECREATIONAL VEHICLE OF ANY RV OCCUPANT WILL BE REMOVED FROM THE PREMISES WITHOUT A JUDICIAL HEARING UPON 72 HOURS WRITTEN NOTICE TO THE OCCUPANT FOR: 1) FAILURE TO PAY FOR SUCH OCCUPANCY, OR TO COMPLY WITH THE RULES AND REGULATIONS OF THIS PARK.
